Hermitage Farms
Water System Improvements

Sealed bids for the construction of Hermitage Farms Water System Improvements will be received in person or via special courier service in the Purchasing Office, Department of General Services, North Run Office Park, 1590 East Parham Road, Henrico VA 23228 or through the regular mail by the U.S. Postal Service, P O Box 90775, Henrico VA 23273-0775 until, but no later than, **2:00 p.m.**, local prevailing time, **August 17, 2010**. Bids will be opened and read aloud at **2:00 p.m., August 18, 2010** at the same location.

A non-mandatory pre-bid conference will be held at **10:00 a.m., July 27, 2010**, at the Public Utilities' Operations Center, 10401 Woodman Road, Glen Allen, Virginia 23060, to review the scope of work and clarify any aspect of the work that may be in question.

The project consists of providing approximately 5,150 linear feet of 4-inch, 6-inch, and 12-inch diameter water mains, replacing 110 existing water services and meter boxes, and installing 11 new fire hydrants throughout the Hermitage Farms subdivision. The project also includes rehabilitating approximately 870 linear feet of 8" sewer main using a cured-in-place-pipe liner, replacing 5 sanitary sewer laterals, and rehabilitating 6 manholes.

Bidders shall be licensed contractors in the Commonwealth of Virginia in accordance with Chapter 11, Title 54.1, Code of Virginia, as amended. See the "Invitation to Bid" in the specifications for the complete bidding requirements.

Beginning on **July 21, 2010**, Bid Documents may be purchased for \$100.00 each set (non-refundable) from Draper Aden Associates, 8090 Villa Park Drive, Richmond, VA, 23228, telephone (804) 264-2228. Checks for the Bid Documents should be payable to County of Henrico, DPU. Only complete sets of Bid Documents will be issued. Provide a separate payment by check of \$15.00 (non-refundable) per set if shipping is required, payable to Draper Aden Associates. Cost includes first-class postage or equivalent only.
